ON-THE-JOB TRAINING

Requirements:

- Employees must be selected and qualified before training begins
- Candidate must have skills gap

PAID INTERNSHIP AND WORK EXPERIENCE TRAINEE PROGRAMS

The Paid Internship/Work Experience programs offer businesses the opportunity to try out potential employees at our cost, while providing needed experiences to candidates lacking specific skills.

Benefits:

- Program is 12 weeks or 360 hours
- Training wages and Workers' Compensation are 100-percent covered
- Interns are local graduates in a relevant field
- Work Experience candidates have desire to work in your selected industry
- You interview/select pre-screened candidates
- Supportive services can be provided
- Trainees, if hired, may qualify for Tax Credits
- Candidate must have skills gap

CUSTOM BUSINESS TRAINING (CBT)

The CBT program assists businesses in meeting training needs of existing employees to maintain a competitive edge in the marketplace.

Benefits:

- Covers 50 percent of out-of-pocket costs

- Ability for business to choose trainer/curriculum

Requirements:

- Businesses must be a private/for-profit
- Employee candidate(s) must make less than \$60,462 annually or \$29.06 per hour
